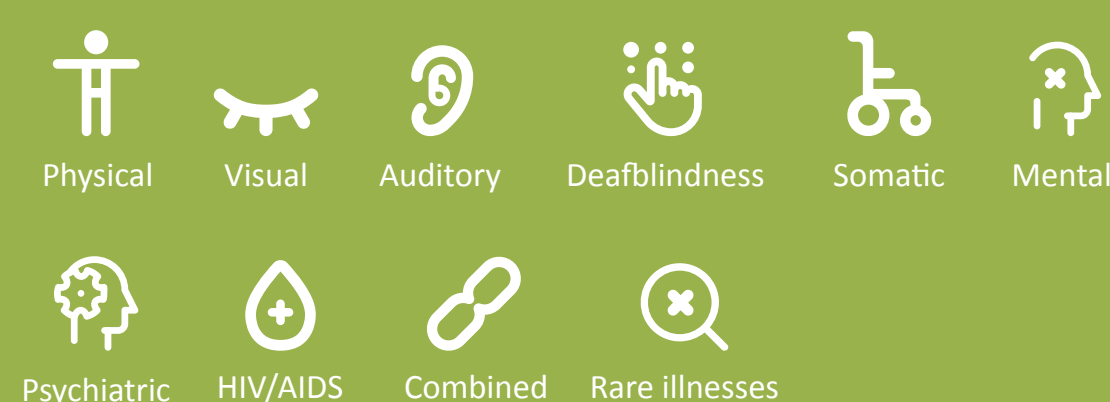


WHO IS ELIGIBLE

Any Romanian citizen, citizen of another state or person without nationality if he/she resides or has a domicile in Romania

If he/she meets the legal criteria

Complex Evaluation Service for Adults with Disabilities

Evaluation Commission for Adults with Disabilities

PLACE OF EVALUATION

- The DGASPC Office, where the person is domiciled
- The domicile of the person, if the person is not able to travel

OBTAINING A DISABILITY CERTIFICATE FOR FORCIBLY DISPLACED PERSONS FROM UKRAINE

Evaluation process

Preparation and submission of the file

Required documents

- Residence permit
- Medical report from the specialist doctor
- Medical history
- Proof of home address
- All documents translated into Romanian and legalized

Submission of the file

At the DGASPC registry office or at the registry office of the town hall of the place of residence

- Through submission
- by post
- by email

Disability assessment and classification

File evaluation

- SECPAH verifies the file and within 5 working days communicates the scheduled date for the physical presentation at the DGASPC headquarters
- **The evaluation is carried out within 60 days**
- The file is then sent to the CEPAH and resolved within a maximum of 15 working days
- CEPAH may request additional documents

Results

Disability status/non-disability status and certificate

SEPAH:

- Comprehensive evaluation report with recommendation for classification or non-classification in disability degree
- Individual rehabilitation and social integration programme



The certificate is mailed to the person's home address



The person can file an appeal

The appeal

Must be submitted within 30 days

- email to the Secretariat of the Superior Commission
- directly to the ANPDPD by post
- to the CEPAH secretariat that issued the disability classification certificate

Deadline for resolution: 60 working days

Benefits and facilities

Social assistance entitlements

- Social Services provided automatically or on request for holders of disability certificates

Benefits

- Severe: Monthly allowance, personal supplementary monthly budget, accompanying allowance free transport
- Profound: Monthly allowance, personal supplementary monthly budget, free transport
- Medium: personal supplementary monthly budget

Facilities

- Health insurance
- Free spa treatment vouchers
- Transport facilities
- Tax facilities
- Access to all forms of education and more
